This fourth supplement (the “**Fourth Supplement**”) is supplemental to, and should be read in conjunction with, the Base Prospectus dated 7 July 2010, as supplemented by the first supplement dated 17 August 2010 (the “**First Supplement**”), the second supplement dated 11 January 2011 (the “**Second Supplement**”) and the third supplement dated 7 March 2011 (the “**Third Supplement**”) (together the “**Base Prospectus**”) which has been prepared by Banque Fédérative Crédit Mutuel (the “**Issuer**”) in relation to its €45,000,000,000 Euro Medium Term Note Programme (the “**Programme**”). The Base Prospectus constitutes a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC (the “**Prospectus Directive**”). The *Autorité des marchés financiers* (the “**AMF**”) granted visa no. 10-232 on 7 July 2010 on the Base Prospectus, visa no. 10-292 on 17 August 2010 on the First Supplement, visa no. 11-008 on 11 January 2011 on the Second Supplement and visa no. 11-065 on 7 March 2011 on the Third Supplement.

Application has been made for approval of the Fourth Supplement to the AMF in its capacity as competent authority pursuant to Article 212-2 of its *Règlement Général* which implements the Prospectus Directive in France.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Fourth Supplement.

To the extent that there is any inconsistency between (a) any statement in this Fourth Supplement or any statement incorporated by reference into this Fourth Supplement and (b) any statement in, or incorporated by reference in, the Base Prospectus, the statements referred to in (a) above will prevail.

Copies of this Fourth Supplement (a) may be obtained, free of charge, at the registered office of the Issuer during normal business hours, (b) will be available on the website of the Issuer (www.bfcm.creditmutuel.fr), (c) will be available on the website of the AMF (www.amf-france.org) and (d) will be available for collection free of charge on any weekday (Saturdays, Sundays and public holidays excepted) at the specified offices of the Fiscal Agent and each Paying Agent during normal business hours so long as any of the Notes are outstanding.

This Fourth Supplement constitutes a supplement to the Base Prospectus for the purposes of Article 16 of the Prospectus Directive and has been prepared in accordance with Article 16.1 of the Prospectus Directive and Article 212-25 of the AMF’s *Règlement Général* for the following purposes:

- (i) to incorporate by reference the French language version of the Issuer’s 2010 *Document de Référence*;
- (ii) to update the cross-reference list in respect of the financial information of BFCM incorporated by reference; and
- (iii) to update the paragraph headed “Financial Summary” in the summary section in respect of the 2010 financial information.

1. PUBLICATION OF THE 2010 DOCUMENT DE RÉFÉRENCE AND INCORPORATION BY REFERENCE

On 28 April 2011, the Issuer published its 2010 *Document de Référence* in French (the “**2010 DR**”). The 2010 DR has been filed with the AMF for the purposes of the Prospectus Directive and article 212-13 of the AMF’s *Règlement Général* with no. D.11-0396.

The 2010 DR is incorporated by reference in, and forms part of, this Fourth Supplement. Copies of the 2010 DR are available free of charge on the website of the Issuer (www.bfcm.creditmutuel.fr) and on the website of the AMF (www.amf-france.org).

The section entitled “*Documents Incorporated by Reference*” on page 27 of the Base Prospectus is hereby deleted in its entirety and replaced with the following:

The 2010 DR includes the audited consolidated annual financial statements of the Issuer for the year ended 31 December 2010 and the related auditors’ report.

Such sections shall be deemed to be incorporated in, and form part of this Base Prospectus, save that any statement contained in this Base Prospectus or in a section which is incorporated by reference herein shall be deemed to be modified or superseded for the purposes of this Base Prospectus to the extent that a statement contained in any section which is subsequently incorporated by reference herein by way of a supplement prepared in accordance with Article 16 of the Prospectus Directive notifies or supersedes such earlier statement (whether expressly, by implication or otherwise). Any statement so modified or superseded shall not except as so modified or superseded, constitute a part of this Base Prospectus.

The Issuer will provide, without charge, to each person to whom a copy of this Base Prospectus has been delivered, upon the oral or written request of such person, a copy of any or all of the documents containing the sections which, or portions of which, are incorporated herein by reference. Written or oral requests for such documents should be directed to the Issuer at its principal office set out at the end of this Base Prospectus. In addition, such documents containing the sections incorporated by reference will be available on the website of the AMF (www.amf-france.org).”

3. SUMMARY

The paragraph headed "Description of the Issuer - Financial Summary" on page 6 of the Base Prospectus which is contained in the section entitled "Summary" is hereby deleted in its entirety and replaced as follows:

"Financial Summary:

At 31 December 2010, BFCM had consolidated assets of €375,264 million (compared to €420,516 million as at 31 December 2009) and shareholders' equity, Group share, of €10,430 million (compared to €9,409 million as at 31 December 2009). Net profit on ordinary activities before taxation for the year ended 31 December 2010 was €2,355 million (compared to €1,504 million for the year ended 31 December 2009). Net profit, Group share, for the year ended 31 December 2010 was €1,405 million (compared to €808 million for the year ended 31 December 2009). These figures have been prepared in accordance with the International Financial Reporting Standards ("IFRS")."

PERSON RESPONSIBLE FOR THE INFORMATION GIVEN IN THE FOURTH SUPPLEMENT

To the best of the Issuer's knowledge (having taken all reasonable care to ensure that such is the case), the information contained in this Fourth Supplement is in accordance with the facts and contains no omission likely to affect its import and the Issuer accepts responsibility accordingly.

The non-consolidated financial statements of the Issuer for the year ended 31 December 2010 were audited by statutory auditors who issued an audit report which is reproduced on pages 90 to 92 of the 2010 DR. This report contains an observation.
